### 1. Introduction

In this module you will identify the apex of your art practice and present it in exhibition form. You are expected to demonstrate your ability to make and exhibit your work. Your exhibition is the form and subject of the examination. For Applied Material practitioners, the ability to communicate ideas is a key skill and capacity. The 'exhibition', should be understood as a term to be widely interpreted and inclusive of a very wide spectrum of art and interdisciplinary activities. This relates also to how and where contemporary artists choose to present their work. Hence gallery and site-specific contexts can be considered.

In meeting the learning outcomes of the Practice Resolution module you are expected to bring forward pertinent art enquiries, experiments, tests, to a significant level of resolution that has been underpinned and informed by the Research module. Your proposed outcome should be managed and manageable but also be ambitious in how it communicates its concerns. You should consider who the artwork is for and how the viewer, user or audience is to engage in and experience the art outcomes.

The Practice Resolution Module will develop an understanding of how artists construct, display, and set up art exhibits. Thus, the importance of understanding 'context' and how to present artworks to others is vital. There are different manifestations e.g. exhibition attendance, artist presentation, testing your own approaches and developing conceptual and technical know-how are all part of fully realising and resolving the artworks.

#### Aims

The aim of this module is to:

- Bring self-directed art research and practice to exhibited resolution.
- Foster critical engagement with and knowledge of a spectrum of contemporary exhibition forms.
- Encourage synthesis of conceptual, technical and material forms.

• Develop ambition and creative risk taking in making and testing exhibition components.

### 2. What will I learn?

On successful completion of this module students will be able to:

- 1. CRITICAL RESEARCH
  - 1.1. Demonstrate in-depth investigation of theme / concept of Proposal / Statement of Intent, through documenting, archiving and drawing.
  - 1.2. Evidence contemporary references and sources in (physical) Notebook and (CAD) Contextual Report.
  - 1.3. Propose Research Strategies and methodologies relevant to the discipline and the fields of study.
- 2. CONCEPT DEVELOPMENT THROUGH MEDIA / DISCIPLINE APPLICATION
  - 2.1. Demonstrate an understanding of pertinent skills and media appropriate to interests and practice.
  - 2.2. Convey how processes and materials support and align with concept / theme through a variety of reiterations, material exploration and sampling.
- 3. REALISATION
  - 3.1. Prove by verbal and visual means, the thinking through the process of making physical outputs.
  - 3.2. Establish relevance of the selected research interests with audience / viewer / user context.
  - 3.3. Illustrate the 'testing' of the work displayed / viewed / engaged and encountered with.
- 4. PROFESSIONALISM:
  - 4.1. Evidence collegiate engagement, participation and best practice conduct.
  - 4.2. Communicate written and verbal communication skills, through VIVA VOCA and written presentations of proposal or statement of intent.

#### **Module content**

This module will develop in-depth interests identified from Trimester1 Research Actioned module (and ongoing Professional Practice module) in a sequential manner. By selecting and focusing on an achievable deliverable to be fully realised, contextualized and tested at examination.

### 3. How will I learn?

In this module, you will learn through:

- Attending the course,
- Evolving and producing artworks,
- Testing relationships between components within and beyond college,



- Exhibition attendance / lecture attendance /field trips and understanding creative risk taking in relation to contemporary forms of exhibition,
- Supported by dialogue with staff, feedback from work-in-progress reviews, seminars, peersharing, and artists' presentations.

## 4. What learning supports are provided?

The module is delivered through seminars and tutorial guidance. Staff work closely with students on their writing elements and with their CAD presentation - first with assignments and then with feedback in tutorials. Students are encouraged to view outputs as *drafts*, as *work-in-progress*, allowing for continual reworking, as the student identifies and defines interests and ideas.

There is a mid-trimester Work-in-Progress Review – where any concerns can be noted and remediated. If additional learning supports are required for writing, this can be provided.

#### 6. How will I be assessed?

Contemporary dissemination forms are understood as being able to suggest or embody very different forms of presentation alluding to white box and black box framing or the now familiar 'expanded' alternatives to these. There is dialogue around live work and performance, around time-based presentations and installations and the ability to exhibit beyond the campus in relation to specific locations or off-site contexts. A variety of approaches can be accommodated through negotiation of the nature and trajectory of individual and collaborative practices.

Works are presented and discussed in studio through an 'exhibition' and Viva Voce before a staff panel.

Students to present work in different formats – notebook sampling / testing to be presented as physical work. Contextual Reports, presented digitally as PDF or PowerPoint.

Assessment is through presentation of in-depth research and experimentation of the proposal or statement of intent. This should be achieved through an edited presentation of distilled material enquiries, demonstrating qualitative enquiry. It should be clearly labelled with name and date.

Note: To select rather than being an exhaustive description of your work is a key consideration. You should be able to lead the examiner through salient components of your enquiry.

# 7. Feedback, results and grading

## 8. What happens if I fail?

Opportunities will be provided during or at the end of Trimester 2 to a student who has not passed the module. Students who are unsuccessful at the end of trimester 2 and after attempting the resit opportunities may be given the opportunity to resit at the end of trimester 3. This will involve a resit fee. At this point, a student failing substantially would be required to repeat (and attend) one or both trimesters in the following year, and pay the required registration fee.

# 9. When and where is this module offered?

This module is delivered in Trimester 2, in the Applied Materials studios, depending on a student's specialisation and using online facilities.

## 10. How will I have the chance to evaluate the module?

It is important to NCAD that students inform the development of teaching and learning at NCAD. We encourage all students to communicate their concerns and their observations about their study to members of staff so that any changes can be made in a timely manner.
