1. Introduction

This module will support learners to effectively orientate their practice within the diverse discourses of contemporary art, critical ecologies theory and spatial and environmental agency. Learning and experience from the Creative Principles in Art and Ecology will be consolidated and reflected upon to lay the basis for deeper and learner specific enquiry. Supported by the three course tutors the genealogies of environmental art and activism, transdisciplinary collaborations and 'more than human worlds' will be explored in these nature-culture intersections.

The aims of this module are to:

- critically evaluate and engage with contemporary debates regarding practice-based research, practice-led research and cognate creative methodologies in Art and Ecology.
- assist participants in developing their own creativity in relation to contemporary creative practice and discourse. This may be as an artist, designer, maker, curator, educator, writer or other.

Module content

Participants will be tasked with orientating themselves theoretically and conceptually as well as grounding themselves in terms of material, medium and human/non-human interaction.

Learners will be supported on a group and individual basis to evolve their practice with respect to coursework as well as an evolved understanding of the NCAD FIELD site and communities of place and interest beyond the FIELD.

Learners will learn through material delivered in advance of each session prescribing group work and also individual initiative. Contact sessions will include formal lecture formats, walks, gatherings,

workshops, and immersive fieldwork. Learners are to then follow up contact sessions that reflect and synthesise their experience and knowledge.

Learners are encouraged to create 'correspondences' with site and both human and non-human agencies encountered. This interaction and exchange will evolve into defined questions and relationships to carry forward into the final Capstone Module.

2. What will I learn?

On successful completion of this module students will be able to:

- 1. DEFINE: Shape knowledge and understanding of practice within Ecology / Natureculture discourse.
- 2. RESOLVE: Develop a transparent iterative process exercising a shared set of practices and terminology relating to ecologies of the urban environment.
- **3.** COMMUNICATE: Disseminate practice with creative 'correspondences' at an appropriate professional standard.

3. How will I learn?

Learners will learn through material delivered in advance of each session prescribing group work and also individual initiative. Contact sessions will include formal lecture formats, walks, gatherings, workshops, and immersive fieldwork. Learners are to then follow up contact sessions with processes that reflect and synthesise their experience and knowledge.

Students will learn through a combination of set activities within the pathway studio and/or base room, and self-directed study within and outside the College.

10. How will I have the chance to evaluate the module?
