### 1. Introduction

---

This module focuses on key modern and contemporary theoretical paradigms concerned with the public sphere and the definition and constitution of publics. Students will consider the role that aesthetic practices can play in the production of social relations and public spaces. Key case studies will be considered and critiqued. Indicative content includes definitions and practices of: The Public Sphere; Relational and Evental Aesthetics; The Event, and key writers such as Habermas, Badiou and Mouffe.

The aims of this module are to:

1. Explore some key theoretical paradigms that inform current debates about the public sphere as they are relevant to contemporary creative practices.
2. Critically analyse the relationships between students' own thought and practice and the various publics it might engage.
3. Support students in developing a good knowledge of the practices, vocabularies, theories and figures that influence contemporary understandings of publics and the public sphere.

## 2. What will I learn?

---

On successful completion of this module students will be able to:

1. **RESEARCH:** Demonstrate a working knowledge of the relevant key theoretical paradigms relating to current debates about the relationships between public spheres and contemporary practices.
2. **ANALYZE:** Apply critical perspectives on the relationships between their theory and practice and the appropriate audiences and stakeholders.
3. **COMMUNICATION:** Successfully articulate and present (in various forms) the practices, vocabularies, theories and figures that are relevant to the public presentation of their work.

### Module content

To reflect the changing nature of contemporary theories, practices and debates relating to publics and public spheres the specific module content changes according to the themes that are deemed to be most relevant to the learning cohort at the time of delivery. At all times there will be careful consideration of the place and relevance of creative practices in the contemporary world.

In the past discussions have included the writings of thinkers such as: Habermas, Mouffe, Butler and perspectives including Queer Theory, Critical Race Theory, Feminism and Critical Theory.

## 3. How will I learn?

---

The classes are student centred discussions based on close analysis and critical reflection of key theoretical texts and positions.
